Meeting called to order by: Sabina Urdes

Sabina welcomed everyone and stated that it was a special night, as it was the LNA Board elections. In addition, two special guests, Mayoral candidates, Ted Wheeler and Sarah Iannarone would be conducting a Q&A, 30 minutes each. She then went on to read the land acknowledgment.

LNA Vote Count:

Sabina announced the vote count for the Lents Neighborhood Association Board elections, making sure to offer a disclaimer laying out the differences in how, due to COVID-19 restrictions, this process differs as compared to previous elections that normally would take place in person. The votes were counted by an independent team from the city along with a couple of current board members. She emphasized that this was merely the vote count and in no way an endorsement of the final results. It is ultimately the board's responsibility to look at the votes to ensure that any discrepancies are investigated and that all possible write in candidates are eligible.

- Public Safety: Natalie Adkins, *28 votes*
- Vice Chair: Jean Fang, *29 votes*
- At-Large 1 year: Katie Penna *27 votes*

Write-Ins:

- At-Large 1 year: Jason Bird *15 votes*
- At-Large 2 year: Nicole Williams: *16 votes*
- At-Large 2 year: Robert Schultz: *1 vote*

Again, Sabina emphasized that these were preliminary numbers that she was reading off her phone in text form. The official numbers would be announced at the next LNA board meeting, which is the second Thursday in November.
